## **Terms and Conditions**

- 1. The contract shall be valid up to 31/03/2022. The expansion or suspension of the contract will be on the discretion of the vehicle hiring institute i.e. Navsari Agricultural University. Therefore, NAU, Navsari will not entertain any request or claim made by the successful bidder (the successful bidder i.e. the quoting party who will be qualified on the technical and financial ground by the competent authority of NAU, Navsari for the award of contract) for extension/suspension or any amendment in the contract period.
- 2. The vehicle will be hired on need basis and determined by the hiring institute.

3. All applicable taxes such as toll tax, passing tax etc. must be borne by the bidder.

4. All vehiclesoffered for the disposal of the contract must be duly registered by State/Central Government for the commercial activities and relevant documents must be submitted along with the quotation.

5. Driver of vehicle should have valid license and he/she will not be eligible for any remuneration from hiring institute. Furthermore, driver's shouldbe physically, mentally fit for disposing his duties. Driver must not have addiction of any narcotics as well as alcohol or drug addiction or any activity which could pose serious safety threat to users.

6. The expenses incurred during travelling like fuel, any breakdown/repair must be borne by the bidders.

- 7. The successful bidders must have to produce bill with minimum rate of one day journey with Rs/km.
- 8. The hired vehicles will be used for inter as well as intra state tours and other officials works.
- 9. The payment of the bill made after the producing of the duly furnished bill to hiring institute.

### 10. Quoted Price

a) The bidder must have to quote for the allitems enlisted by the hiring institute. Corrections, if any, shall be made by crossing out, initialing, dating and re writing.

b) All duties, taxes and other levies payable shall be included in the total price.

- c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The prices shall be quoted in Indian Rupees only.

11. Each bidder shall submit only one quotation.

## 12. Validity of Quotation
